- All persons submitting a request for consideration will be given an equal and fair assessment of their candidate's qualifications and willingness to serve on the MAYLA Board. The Nominating Committee will review all requests and give their recommendation for the top nominee(s) for each position to the MAYLA Board no later than one week prior to Election Day. The Nominating Committee will recommend a minimum of one (1) person and a maximum of three (3) persons for every open position.
- Evaluations by the Nominating Committee will be done using this application form and the MAYLA Nominating Committee Candidate Qualities Form (to be filled out by the Nominating Committee).
- This form must be submitted no later than thirty (30) days prior to the scheduled day of elections. Failure to complete this form in a timely manner will prevent a person from being recommended by the Nominating Committee to the MAYLA Board of Directors on Election Day.
- If your candidate's name is not recommended by the Nomination Committee, you will still have the ability to nominate your candidate on the day that MAYLA elections are held. This nomination from the floor can be made by any person present at the MAYLA Member's meeting.
